## City of Lake Bronson Regular Council Meeting Minutes

## **January 21, 2020**

**CALL MEETING TO ORDER:** Acting Mayor S. Strom called the meeting to order at 5:30 pm. Council members present were, L. Kowaliuk, S. Shablow & P. Matthew. City employee present was S. Lund. Public present was D. Brown.

**CITIZENS CONCERNS/COMMENTS:** Brown asked if the high snow piles by the Lutheran church could be removed because they obstruct the view of oncoming traffic. Strom will try to take care of this on the weekend.

**OLD BUSINESS:** Yard Cleanup: Tabled until spring. The council is concerned with the dangers of one vacant home. Strom will ask the home owner again to cover the doors with plywood. **Lagoon Fences:** Tabled until spring.
